





Common Proficiency Course (CPC)

An entry level test for Chartered Accountancy course held twice in a year in June & December

- ► CPT is a test of four subjects :
 - Fundamentals of Accounting (60 Marks)
 - Mercantile Laws (40 Marks)

 - Quantitative Aptitude (50 Marks)

The papers consist of Multiple Choice Questions (MCQ's) with negative marking of 0.25 marks for every incorrect answer
