It was decided that any incident on ragging if noticed should be recorded on the spot and the student indulging in any such activities should be brought to the notice of the concerned person in authority immediately.

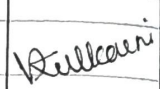
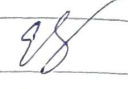

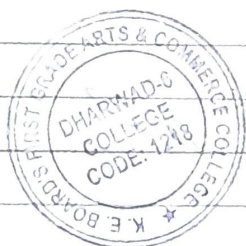

The second meeting of anti-ragging committee was held on in principal's chamber. The convener welcomed the members of the committee.

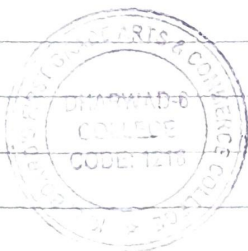
Discussion :
